Mile High Radio Club Constitution

1 ARTICLE I 2 The name of this Club: "Mile High Radio Club", The official address shall be P. O. Box 1204, Idyllwild, California 92549. 3 ARTICLE II 4 We, the members of this Club, wishing to secure the pleasures and benefits of an association of persons commonly interested 5 in Amateur radio, constitute ourselves the Mile High Radio Club and enact this Constitution as our governing law. It shall be 6 our purpose to further the exchange of information and cooperation between members, promote radio knowledge, fraternalism, and individual operating efficiency, and so to conduct such Club programs and activities as to advance the general interest and welfare of Amateur radio in the community. Further, the Club will also enhance the emergency services 9 of the San Jacinto Mountain region, support the R.A.C.E.S. (Radio Amateur Civil Emergency Services) program, and 10 encourage the advancement of the individual in Amateur radio. 11 ARTICLE III 12 Section 1. This Club is a non-profit organization and is not organized for the private gain of any person or persons. All activities of the Club shall be conducted in such a manner that no part of any income shall benefit any individual member. Section 2. The specific purposes of this Club are to: 15 Promote sociability, fellowship, cooperation, and an exchange of ideas among those interested in Amateur Radio; 16 To bring qualified experts in Amateur radio, electronics, and related fields to Idyllwild for seminars and workshops; 17 To promote and support the Radio Amateur Civil Emergency Service's (R.A.C.E.S.) Mountain District's emergency 18 and community communications missions by providing equipment, and financial, administrative, and fund-raising 19 assistance in every way possible; 20 To further the interest in the art of Amateur radio and related electronics by inspiring personal achievements and 21 instructing interested persons and members in Amateur Radio and electronics; 22. To install, maintain and operate an Amateur Radio repeater station for the benefit of members and emergency 23 services as described above. 24 ARTICLE IV Section 1. This Club is organized and operated within the meaning of Section 501(c)(3) of the Internal Revenue Code. 26 Section 2.
